The ownership percentages reported are based on 105,257,014 outstanding Ordinary Shares, based upon the closing of the Issuer's initial public offering of American Depositary Shares ("ADSs"), as reported in the Issuer's prospectus filed with the SEC on November 2, 2021.

The Fund directly holds 6,167,412 Ordinary Shares, of which 1,375,374 are represented by ADSs. RA Capital Nexus Fund II, L.P. (the "Nexus Fund II") holds 1,016,002 Ordinary Shares, of which 87,126 are represented by ADSs. A separately managed account (the "Account") holds 471,601 Ordinary Shares.

RA Capital Healthcare Fund GP, LLC is the general partner of the Fund and RA Capital Nexus Fund II GP, LLC is the general partner of the Nexus Fund II. The general partner of RA Capital is RA Capital Management GP, LLC, of which Dr. Kolchinsky and Mr. Shah are the controlling persons. RA Capital serves as investment adviser for the Fund, the Nexus Fund II, and the Account and may be deemed a beneficial owner, for purposes of Section 13(d) of the Securities Exchange Act of 1934 (the "Act"), of any securities of the Issuer held by the Fund, the Nexus Fund II, and the Account. The Fund, the Nexus Fund II and the Account have delegated to RA Capital the sole power to vote and the sole power to dispose of all securities held in their respective portfolios, including the shares of the Issuer's Common Stock reported herein. Because the Fund, the Nexus Fund II and the Account have divested themselves of voting and investment power over the reported securities they hold and may not revoke that delegation on less than 61 days' notice, the Fund, the Nexus Fund II and the Account disclaim beneficial ownership of the securities they hold for purposes of Section 13(d) of the Act and therefore disclaim any obligation to report ownership of the reported securities under Section 13(d) of the Act. As managers of RA Capital, Dr. Kolchinsky and Mr. Shah may be deemed beneficial owners, for purposes of Section 13(d) of the Act, of any securities reported in this Schedule 13G Statement (the "Statement") other than for the purpose of determining their obligations under Section 13(d) of the Act, and the filing of the Statement shall not be deemed an admission that either RA Capital, Dr. Kolchinsky, or Mr. Shah is the beneficial owner of such securities for any other purpose.
